Executive Director Cincinnati Experience



Mileham has been working with CX (formerly Source Cincinnati) since its founding in 2014, helping to craft and feed stories to national media publications about Cincinnati Center City Development Corp's (3CDC) work and then the 1819 Innovation Hub, and assumed the executive director role in 2020.

Mileham has decades of senior leadership experience working in multiple industries to drive revenue, maximize operational efficiencies, build effective leadership teams, and create strong brand awareness. She also is president of Mileham Consulting, Inc., a consulting firm established in January 2017, specializing in business development strategy, change management, and strategic marketing and communications for both non-profit and for-profit clients.

The Catalytic Fund has a \$16,000,000 real estate investment fund its uses to provide equity investments, secondary/mezzanine, bridge loans and other creative financing structures to assist quality residential and mixed-use projects.

Schroer has 35+ years of experience as a real estate professional. She began her real estate career as a financial analyst with Urban Investment and Development Company in Chicago, developer of large urban mixed-use projects such as Water Tower Place in Chicago and Copley Place in Boston. In 1984, she joined Corporex Companies and held positions of Financial Analyst, Manager – Capital Acquisition, Director – Mortgage & Equity Group, and Senior Vice President and Member of Corporex's Executive Management Board. Weir brings years of experience in the social services and consumer sectors for a unique perspective on healthcare and the needs of our region's families.

She became the first ever female President and CEO of United Way of Greater Cincinnati in March 2020 where she advocates for new voices and new solutions to decades-old community challenges, focusing on three key areas: educational success, financial empowerment and housing security.

Prior to her role at the United Way, Weir had been director of Hamilton County Job and Family Services since 2007.

As director of Hamilton County Job and Family Services, Weir led a department with 800 employees that served 500,000 Hamilton County residents each year. She was responsible for an agency with a \$2.4 billion annual budget charged with local child protection, elder protection, publicly-funded child care, child support enforcement, workforce development, cash assistance, food stamp disbursement, and Medicaid disbursement.

Weir worked her way up from being Children's Services line worker, a position she accepted upon joining the agency in 1993. She held leadership positions in the areas of child welfare, public assistance, child support and other areas before being named director. Under her leadership, the agency became a state leader in efficiency, accuracy and creativity, winning 16 different awards for innovation from the National Association of Counties during her tenure, more than any other government agency in Ohio. One initiative, the Trucking Partnership, was named one of the National Association of Counties' 100 Brilliant Ideas at Work in 2018.

Almaguer is the Chief of Staff at the Office of Innovation at the University of Cincinnati. He plays a key role in supporting the university's innovation initiatives and strategic planning efforts. In his role as the Assistant Vice President for Technology Transfer at the University of Cincinnati's Office of Innovation, Pinski leads a team that manages the university's intellectual property portfolio, supporting faculty and staff in filing for patent protection and negotiating licensing agreements.

Pinski has been with the University of Cincinnati since 2007 and has held various positions related to technology transfer. Upon successfully graduating from law school in May 2006, he moved from Extern to Licensing Associate, responsible for managing material transfer agreements and non-disclosure agreements. Within a year, he became responsible for UC's physical sciences portfolio. In January 2010, he became Director and was recently promoted to Assistant Vice President. During his time as Director and Assistant Vice President, UC has spun out over 30 companies, which have raised over \$75 million dollars in investment. He was named Assistant Vice President in 20201. His team is based at the 1819 Innovation Hub, which is part of the Cincinnati Innovation District.





#### Laura N. Brunner

President & CEO
The Port of Greater Cincinnati Development Authority

Brunner is President and Chief Executive Officer of The Port of Greater Cincinnati Development Authority (The Port), an economic development agency based in Cincinnati, Ohio. For more than a decade, Brunner has led The Port with her impassioned efforts to fix broken real estate in order to reduce wealth disparities, increase homeownership and grow manufacturing jobs.

Throughout her career, Brunner has consistently challenged the status quo and leaned into risk. When at developer Al. Neyer, the opportunity arose to transform the Vernon Manor into offices. Brunner saw an opportunity for minority investors to own a majority interest in the project. She was successful in making that a reality, and now over 700 employees of Cincinnati Children's Hospital work in the redeveloped hotel.

Brunner gained national recognition in 2022 when she led the unprecedented effort to acquire 194 single-family homes from an out-of-town investor to keep the American dream of home ownership alive for many Cincinnatians. She also blazed new trails in sustainable investing when The Port issued \$11 million in social impact bonds for the creation of advanced manufacturing jobs.





Dan Schimberg

President Uptown Rental Properties

Schimberg founded Uptown Rentals in 1985 to fill a niche in off-campus student housing at the University of Cincinnati. Starting with the rehab of one house, Uptown has grown to own and manage over 4,000 multi-family units and 200,000 SF of commercial space in the Greater Cincinnati area.

Under Schimberg's leadership, Uptown Rental Properties has renovated hundreds of structures and developed 2,600+ multi-family units from the ground-up in Cincinnati and Florida.

Uptown Rental Properties is committed to providing a wide variety of housing choices catering to professionals, off-campus student housing as well as work force housing.
